

# SPAH Scottish Paediatric and Adult Haemoglobinopathies Network

#### **Background**

The term 'haemoglobinopathy' covers a range of inherited blood conditions in which haemoglobin (the oxygen carrying protein in red blood cells) is either qualitatively or quantitatively abnormal. The two main disease groups are Sickle Cell Disease (SCD) and Thalassaemia. These are lifelong genetic disorders that often result in complex medical problems.

The Scottish Paediatric and Adult Haemoglobinopathies Network (SPAH) has a remit to ensure that equitable, high quality care is delivered promptly to patients with haemoglobinopathies at all points in their journey, by a multidisciplinary health care team with knowledge of the condition. This includes minimising the risk of infections by immunisation and prophylaxis, management of drug therapies, transfusion needs and consequent iron overload to improve long-term health. Patient and parent education is also important to minimise the occurrence of sickle cell acute complications and managing these at home, where possible, thus reducing disruption to education and employment.

Due to the complex nature of Sickle Cell Disease and Thalassaemia early involvement of the specialist Haematology team is crucial to ensuring good patient outcomes. The network connects the various points of service delivery in the patient pathway and supports clinicians to work together effectively. Patients are primarily treated in five centres (Aberdeen, Dundee, Edinburgh, Glasgow and Forth Valley), with equity of care supported through the use of standard guidelines and networking amongst the clinicians to share best practice.

#### **Current Position**

Understandably NHSScotland's priority during 2021/22 has continued to be to manage the impact of COVID-19 this has seen clinical and other resource diverted from network activity.

Throughout the course of the year the network has undertaken to monitor workplan objectives to minimise the impact on the SPAH community including limiting communications and requests to staff unless the work carried out would directly benefit patients. Projects not requiring the involvement of clinicians have been progressed by the SPAH Core Team.

The network has progressed the majority of workplan objectives. however due to clinician capacity a number are taking longer to complete than expected due to the ongoing COVID-19 pandemic and pressures on the clinical service. Following a directive from the Chief Operating Officer, network activity was paused from December to March, which also had an impact on workplan objectives being progressed. Dr Susan Baird, who has been Lead Clinician of the network since 2017, stepped down from her role in June. The network thanks Dr Baird for her leadership and commitment over the past 4 years and is pleased to report that she will continue as an active member of the network. The network was pleased to welcome Dr Louisa McIlwaine to the role of Network Lead Clinician in September.

#### **Lead Clinician Reflections**

I have been involved in the SPAH network since it started and have seen the difference that it has made to patients and clinicians. I am therefore very honoured to have the role of lead clinician.

The network supports patient and clinicians in a variety of ways. The SPAH website provides clinicians across Scotland with access to emergency protocols. Similarly, provides a trustworthy source of information for patients and families.

National multidisciplinary meetings support clinicians across Scotland and in the last year, through SPAH, we have developed links with the experts in West London Haemoglobinopathy Coordinating Centre providing expert support.

The patient numbers continue to grow, and the SPAH clinical audit system (CAS) provides a valuable data resource which allows us not only to identify how many patients we have, but also where service development is required. Like any data collection system the information obtained is only as useful as that which is put in. There are barriers to data collection within daily clinical practice, but I hope to focus on certain areas that can influence patient care.

The network has made a big difference in its first decade, but there remain many challenges, some of which we are hoping to address in the next few years. The transition from paediatric to adult care is not easy and involves not only a change in caregiver but often hospital. This is a scary and challenging time and we are looking to involve our young patients to help us identify where improvements can be made. Increasingly some of our patients are moving away from the big cities, and so ensuring every health board in Scotland has designated links to the SPAH guidelines, MDTs and other resources is the aim of our national mapping exercise, which recently started.

Teams has allowed some essential educational sessions to continue during the pandemic but we look forward to the time when we can resume the patient/parent education meetings. It had been hoped that these would be something that could be done in person this year, but with the threat of covid still around and the vulnerability of the patient group we have decided to explore whether some form of online activity would be of interest.

Finally, this network would not be able to function without the support of the Programme Team and I wish to extend my gratitude to them for their hard work and support over the last year.

#### **Highlights**

Scottish Ambulance Service & Improvements to Pre-Hospital Care: The network is continuing its collaboration with the Scottish Ambulance Service with work underway to develop a hand held patient alert card containing key information about their condition and how it should be managed. A patient information leaflet on how to call an ambulance to highlight the needs of a patient experiencing a sickle cell crisis has also been drafted and considered by stakeholders.

**Education and information:** This remains a priority for the network, with the aim to continue to build a range of resources for both professionals and other stakeholders. Current resources are easily accessible through the website and provided at clinics and the Nurse Sub-Group is now well established with regular meetings to review patient information as well as provide peer support and education.

Susan Baird presented on haemoglobinopathies at the expertise to Royal College of Physicians of Edinburgh Event on 27 April 2021 and there have been various local hospital educational meetings run by SPAH members to improve patient care.


Adult Ferriscan Service: The Ferriscan service previously provided to all adult patients at risk of transfusion related iron overload in Scotland at two locations (Grampian and Forth Valley) is no longer available. To mitigate the impact of Ferriscan being unavailable a short term pathway has been developed supporting referral of adult patients for scanning at the Queen Elizabeth University Hospital in Glasgow which commenced in May 2021. The network is continuing to explore the feasibility of scans being provided locally in the NHS.

**Review of Services:** A survey has been circulated to gain feedback from haematologists in relation to current services and to raise awareness of the network and availability of SPAH protocols. SPAH has also enquired with Health Board areas who do not have patients registered on the Clinical Audit System to ensure their patients are being added to the database. The aim is to identify interested clinicians in each Health Board and the findings will be used to identify any improvements to be taken forward.

# Patients with Haemoglobinopathies registered on the National Clinical Audit System (CAS)

The Clinical Audit System continues to be the national register for SPAH. There are a total of 333 active follow up patients currently registered on CAS, an increase of 30 patients from 2020/21.


Patients have been registered on CAS since 2013 with annual figures reported since 2014/15 showing a continued increase in the number of patients living with haemoglobinopathies in Scotland.




The largest group is patients with sickle cell disease, with the distribution across Scotland shown in the tables below:


The paediatric and adult patients registered on CAS by Health Board of Residence and by 100k of Head of Population is shown in the next two slides.








#### **Reporting Against SPAH Key Performance Indicators**


Measuring performance has once again been a major objective for the network during 2020/21. Clinicians have continued to provide data to measure against 7 Key Performance Indicators (KPIs). KPI data which is available within CAS is provided below.




















#### **Discussion**

It is recognised by the clinicians that much of the late or absent KPI data relates to not returning the information to the SPAH team due to clinical pressures rather than reviews and assessments not being undertaken. It is however clear that improvement in data returns in the future is required to ascertain that this is true.

There has been a true reduction in Transcranial Doppler scanning and annual review assessments due to Covid 19 and the restrictions on clinical activity. The TCDs and reviews that have been undertaken have been prioritised for the highest risk groups, and work is ongoing to catch up on the rest.

#### **Exceptions**

The following objectives were not delivered as, given the situation caused by the pandemic, the network was keen to minimise the burden on clinicians.

Patient/Family event: All face to face events were cancelled for 2021/2022.

**SPAH paediatric bone marrow transplant referral pathway**: this was not progressed during 2021/22 and has been carried forward to 2022/23 workplan.

**Time to analgesia audit:** this was not progressed during 2021/22 and due to clinician capacity will not be carried forward to the 2022/23 workplan however will be discussed again for future years.
